Damage Waiver: At the option of the client, Yard Gear Inc. agrees to accept the liability for equipment damage resulting from authorized use as defined in the equipment manual, for the equipment listed above, in exchange for a premium charge of 8% of the total rental before taxes. This damage waiver does not include coverage of injury in any form, whether directly or indirectly resulting from the use of the rented equipment. Further, this damage waiver does not include equipment damage resulting from: misuse, lack of required maintenance (i.e. : oil check), lack of training or knowledge, or inadequate protection during transport.

1) Yard Gear Inc. agrees to rent the equipment described on the reverse of this form, for the sum indicated.

2) Renter shall pay Yard Gear Inc. the sum indicated in the total on the reverse of this form as payment for the rental payable prior to equipment rental using a valid and approved credit card.

3) Renter shall pay a **security deposit** of \$ [redacted]. The security deposit is in addition to the rental payment. Only after all equipment has been returned to Yard Gear Inc. and found to be in good condition and repair shall the security deposit be reimbursed to the Renter. The Renter agrees to pay the full retail value of any equipment that is not returned or is returned damaged. **OR** Pre-authorized charge taken on the renter's credit card and attached as indicated on page one. Full **retail value** of the equipment described below is \$ [redacted].

4) Renter shall, during the rental term, keep and maintain the rented equipment in good condition and repair and agrees to be responsible for any damage or destruction to rented equipment with the exception of specific terms contained in the damage waiver, if accepted, and premium is paid. Renter agrees to return said property in clean condition or agree to cleaning charges at the current shop rate (\$65 / hour, minimum 1/2 hour).

5) Regardless of cause, the Renter and its employees or agents waive the right to make any claim against Yard Gear Inc. for loss of anticipatory profits, or any other indirect, special, or consequential damages. Additionally, Renter and its employees or agents waive any right to make any claim against Yard Gear Inc. for damages resulting from misuse of the equipment or for personal injury or death resulting from use of the equipment. It is the Renter's responsibility to familiarize him or her with the use, care, and safety precautions for the particular equipment rented from Yard Gear Inc. It is understood that the Renter, by renting said equipment, is knowledgeable and capable of the safe operation of each piece of equipment rented. It is also agreed that persons other than the renter may, at times, use the rented equipment; the Renter agrees to be responsible for all users of the equipment during the rental period specified on page one or until the equipment is returned to Yard Gear Inc. under the same conditions as the Renter.
